

## **Terms of Use**

This Terms of Use statement (the “Terms of Use” or the “Terms”) applies only to the website at [www.overcomingobstacles.org](http://www.overcomingobstacles.org) (the “Website”). The Website is owned and operated by Community for Education Foundation, Inc. (DBA Overcoming Obstacles) (“Overcoming Obstacles”).

### **PLEASE READ THE TERMS OF USE CAREFULLY BEFORE USING THE WEBSITE.**

By accessing and using the Website or by clicking a box that states that you accept and agree to the Terms, you represent that you have read, understood, accept, and agree to be bound by the Terms. If you do not understand the Terms or do not agree to be bound by the Terms, including our Privacy Policy, which is incorporated by reference into the Terms of Use, or are not legally competent to enter into contracts, you are not authorized to use the Website and must leave the Website. Please read our Privacy Policy for complete information relating to the collection and use of your personal information.

### ***Changes and Updates***

Overcoming Obstacles may at any time, in its sole discretion, add to, amend, modify, or delete any of the Terms of Use. The Terms of Use and each revision thereof are effective when posted on the Website. In addition to posting the revised Terms of Use, Overcoming Obstacles may notify you of material changes to the Terms by taking other actions, such as displaying a notice on the Website stating that Overcoming Obstacles has posted new Terms of Use containing a material change in the terms under which Overcoming Obstacles offers the Website. However, Overcoming Obstacles has no obligation to take any action with respect to any change in the Terms other than posting the revised Terms of Use. OVERCOMING OBSTACLES and the interlocking circles logo are registered trademarks of Overcoming Obstacles. Nothing in the Terms or on the Website will be construed as granting, by implication, estoppel, or otherwise, any license, right, or permission to use any Trademark displayed in the Materials without the owner’s prior written permission. Unauthorized use of any Trademark displayed in the Materials in any manner is strictly prohibited.

### *License to Use the Website*

Overcoming Obstacles grants to each user of the Website a freely revocable, worldwide, royalty-free, non-transferable, non-assignable, non-sublicensable, non-exclusive license to access the Website and use the Materials only for uses that are non-commercial, educational, and lawful and only in accord with the Terms of Use (the “Website License”). ### *The Curriculum License*

Overcoming Obstacles grants to all users of the Website a freely revocable, worldwide, royalty-free, non-transferable, non-assignable, non-sublicensable, non-exclusive license to use the Curriculum only for uses that are non-commercial, educational, and lawful and only in accord with the Terms of Use (the “Curriculum License”).

Except as provided in this paragraph, you shall not reproduce, store in a retrieval system, distribute, publicly perform, or publicly display any part of the Curriculum, in each case in any form or by any means (including, without limitation, photocopying, recording, or any other electronic or mechanical means or otherwise). Any use of the Curriculum other than as explicitly permitted herein requires Overcoming Obstacles’ prior written permission, which Overcoming Obstacles may grant or withhold in its discretion.
